## **Updates From the CSHA STAR**

his year, the Medicaid/Medicare Fraud Control Unit (MFCU) brought investigations of fraud against more than 30 speechlanguage pathologists (SLPs) based on billing practices that were communicated as appropriate and allowed by Medicaid employees in 2013-2016. CSHA was able to obtain an extended contract with lobbyist Jennifer Mello with Brandeberry McKenna Public Affairs and cooperated with lawyers who were already involved with some of the affected SLPs to communicate with both the Attorney General's office, MFCU and the Health Care Policy and Finance Department (HCPF: Medicaid). In August, the cases were closed with the MFCU, meaning all fraud investigations were closed. This is an unprecedented outcome and one that we are all proud of accomplishing. The MFCU sent all information to the Medicaid Audit and Compliance Division for review for possible overpayment. We have not received communication on any outcome within the department regarding the status of these cases within the Medicaid Audit and Compliance Division.

Medicaid is currently in the 2nd cycle of the Rate Review Committee and this includes the Outpatient Speech Therapy Benefit. The STAR representative recently attended the November 2016 meeting and presented information regarding speech therapy services and a survey of 77 SLPs in a variety of settings regarding Medicaid Billing. This committee reviews all Medicaid rates and provides a summary and recommendations to the Joint Budget Committee who makes the final rate setting decisions. This process will not affect the rates for speech therapy services until November 2017. The STAR plans to attend the Joint Budget Committee meeting in the spring and hopes to meet with members of the rate review committee again prior to that time. She would like to seek providers who work in specific settings to provide information to the committee members on how the medicaid rates affect them: early intervention, feeding, home care, clinic based.

## **CSHA Lobbyist Report**

The law regulating speech-language pathologists is scheduled to sunset in 2017. Under Colorado law, most regulatory structures sunset after a certain number of years. CSHA retained Brandeberry McKenna Public Affairs (BBMK) early in 2016 to assist the Association with retaining, and perhaps even improving, regulation by the Department of Regulatory Agencies (DORA). Over the last year, BBMK worked closely with Association leadership to manage the first part of the sunset process, which is when the Policy Office at DORA examines the profession and makes a recommendation as to whether regulation should continue. As part of this process, our lobbyists helped set up site visits at locations like Craig Hospital to demonstrate the complexity of services performed by speech-language pathologists (SLPs) and to underscore the vulnerability of some of our patients. We were thrilled when DORA's report came out in mid-October recommending that regulation continue.

In 2017, to complete the process, we must pass legislation. Our lobbyist has been working to get the best possible sponsors for a bill. Additionally, we have identified some specific components of the current regulatory scheme that we will seek to improve. BBMK is exploring how to make it easier for SLPs who have a CDE license to interact with DORA and how to build in a longer amount of time before the law sunsets again. As the legislation works its way through the Colorado legislature in 2017, we will work with BBMK to ensure we present a strong case for why SLPs should continue to be regulated in Colorado.

Additionally, there was an incredibly unfortunate situation in 2017 where several SLPs who provide services in the Medicaid program came under investigation for fraud. Working with BBMK, CSHA was able to make a strong case to the Governor's Office and to Health Care Policy and Financing (the state's Medicaid agency), that providers had relied on guidance given by the agency. BBMK advocated very strongly that it was incredibly unfair and unreasonable to accuse providers of fraud, even if the guidance provided was not consistent with federal law. A handful of providers hired legal counsel, and those efforts were critical as well. Together, we were able to ensure that all fraud cases opened by the Attorney General's office were dropped.
