President's Letter



Your CSHA Board of Directors hopes you are all well and enjoying sunny days! It seems warmer weather brings a new busyness to our lives – this is true for your CSHA Board, as well. In addition to our daily commitments to work and family, we are continuing to move forward in achieving the initiatives set by the Board for 2016.

CSHA has contracted with a lobbyist who is guiding us through the recertification process for 2017. The certification bill is currently being reviewed by a public policy analyst who will make his recommendations to the state later this summer. CSHA Board members have followed through with the lobbyist's recommendations to communicate directly with the public policy analyst, schedule observation opportunities and provide names of professionals who are commenting to support the reauthorization of the law. ASHA has also done its part in a number of ways. CSHA was successful in applying for and receiving a \$9,000 grant from ASHA to go toward expenses of the recertification process.

Redesign of the CSHA website is underway, and we think you are going to love the changes! Our goal is to roll out the new website in November. Please feel free to contact us if you have comments and ideas for the new design. Ultimately, our goal is to make the website more functional and accessible for our members, students and consumers.

 Ms. Jen Carter is a Board Certified Specialist in Swallowing (BCS-S) and has more than 20 years of experience treating patients with dysphagia. She currently has a private practice in Englewood, Colorado, the Carter Swallowing Center, specializing in the treatment of dysphagia. She also organizes the Denver Dysphagia Rounds journal club, which is open to any interested dysphagia clinicians.

Ms. Carter will present Myofascial Release in Dysphagia Treatment for Patients Following Head/Neck Cancer.

• Dr. Patrick J. Rydell is the Founder and Director of the Rocky Mountain Autism Center, Inc. and Autism On Call, LLC, in Lone Tree, Colorado. With more than 35 years of practice ("on the floor") in the field of autism spectrum disorder (ASD), he has provided international and national training, workshops, consultations and program development to government agencies, medical facilities, universities, school districts, professionals and families. His doctorate (University of Nebraska-Lincoln) was earned through a National Institute of Health Leadership in Autism grant (1989) and he has a double master's degree (Southern Illinois University-Carbondale) in speech pathology and special education with a program emphasis in early childhood and autism spectrum disorder.
