As the Board has become diverse in practice representation, so has its focus in supporting clinicians in a variety of settings. CSHA is currently expanding the benefits of membership to include webinars offered on the CSHA website at low rates to members. CSHA recognizes how difficult it can be to travel to Denver, Grand Junction or Colorado Springs to attend a Conference. CSHA will provide a stipend to presenters and take care of all the details.

Members of the CSHA Board and other volunteers had the opportunity to testify before the Colorado House and Senate in support of the SLP Bill (SB 17-108). The SLP Bill renewal was signed by Governor John Hickenlooper on May 9. The SLP Bill continues the certification of speech-language pathologists (SLPs) in Coloado and ensures consumers continue to receive quality speech-language pathology services. Moving forward, the SLP Bill sets up Colorado SLPs in an ideal position to create or join an interstate compact licensure bill in the future. ASHA is in support of interstate compact licensures to facilitate telehealth SLP practice and professionals moving from one state to another due to relocation or as travelers. Interstate compact licensure is becoming the future for rehabilitation therapists. The SLP Bill will be up for review again in 2018 so stay put and please reach out to the Board with concerns or comments. The CSHA Board, as always, will reach out to the membership requesting feedback on desired changes or improvements to be addressed during the review process in 2018.

In conversations with peers, many have asked me, "why join CSHA?" Here is my answer: for the opportunities in continuing education, leadership development, updated and timely legislative information, networking, professional strength in numbers and to serve the profession beyond providing patient care. Your dues make it possible to keep Colorado and the SLP profession in Colorado represented and united. Con August 5 at the Children's Hospital Colorado in Aurora. It is a two-track Conference offering speakers and topics for adult and pediatric based clinicians.

**Cathy Lazarus, PhD, CCC-SLP,** who is the research director of the Functional Outcomes Research Center and a practicing speechlanguage pathologist for the Thyroid Head and Neck Research Center (THANC) will be speaking all day about management of treated head and neck cancer patients. At the same time, the pediatric track will be offered by three consecutive presenters who will be doing short presentations on feeding strategies, learning principles and social communication. The presenters in the pediatric track are faculty and/or practicing clinicians in Colorado.

Melanie Potock, MA, CCC-SLP is an international speaker on parenting and feeding babies, toddlers and school-age children. She is the co-author of the award-winning *Raising a Healthy Happy Eater* & Baby Self-Feeding: A Stage-by-Stage Guide to Setting Your Child on the Path to Adventurous Eating (2015) and Baby Self-Feeding: Solutions for Introducing Purees and Solids to Create Lifelong Healthy Eating Habits (2016). Her new book, Adventures in Veggieland: Help Your Kids Learn to Love Vegetables with 101 Easy Activities and Recipes will be released in October 2017. We will be raffling one of her books during the Conference and at the CSHA August Board meeting happening immediately after the Conference. All attendees are invited to attend the CSHA board meeting.

**Christina Meyers-Denman, PhD, CCC-SLP,** is an assistant professor at the University of Colorado in Boulder. Her teaching and research is focused on child language development and disorders, and intervention practices for children with language disorders.

**Kim Murza** is an assistant professor at the University of Northern Colorado. Her main research area is the development, delivery, and evaluation of high-quality professional learning in the school. Additional research interests include assessment and intervention for individuals with autism spectrum disorder, systematic review and meta-analysis, strategic learning, inference generation, and disciplinary literacy.

Department of Health Care Policy & Financing

The Department of Health Care Policy and Financing, which administers Health First Colorado (Colorado's Medicaid program) and its new Fiscal Agent have been posting information to help providers learn to navigate the new provider claims system, Colorado interChange. Over the past 18 months, more than 43,700 providers have enrolled in the new system that went live on March 1, 2017. Since going live, the new claims system has paid more than half a billion dollars in claims to providers. This is on pace with the volume of payments made in the old system.

With any new system launch, there is a learning curve and frequent questions about using the new system. The top reasons for calls to the provider call center are to check on claims and to ask provider enrollment questions. Some examples of the top denial of claims reasons include: revalidation was not started or completed, the wrong combination of provider type, specialty and taxonomy was used on the claim and the wrong NPI number was used on the claim. The department and its fiscal agent have developed resources that can help providers with these frequent questions about using the new system.

## Legislative Update

C B17-108, the legislation that continues state certification for **J**Colorado speech-language pathologists (SLPs), was passed on April 3, 2017. Governor John Hickenlooper signed the bill into law on May 9, 2017. The new act will go into effect on August 9, 2017. One important change is the Department of Regulatory Affairs (DORA) now recognizes speech-language pathologists who possess a special service provider license issued by the Colorado Department of Education (CDE). Therefore, SLPs who are licensed through CDE will no longer be required to obtain dual certification through DORA in order to practice in settings outside of schools. The Colorado Speech-Language-Hearing Association and the their lobbyist, Brandeberry-McKenna Public Affairs, have been working on this legislation since 2015. This is one way in which CSHA has been working for you. SB17-108 will sunset on September 1, 2022. To read the signed act, follow this link:

As this school year ends, some things remain in a state of transition. Medicaid funding is in a precarious position due to changes at the federal level and there is simply a great deal of uncertainty regarding the future at this time. CDE's Speech-Language Advisory Council (SLAC) is continuing the work of revising the Communication Rating Scales as well as brainstorming ideas for different webinars next year. Be on the lookout for that information.

I hope to have more information to share with you all next quarter. I am looking forward to serving you in this position and want to wish everyone a restful and rejuvenating summer!

A: Depends on the setting you are employed in. Outside of the schools and based on DORA requirements, you need 10 Professional Development Activities (PDAs) per year. Here is the link for further information:
