ASHA 2015 Convention in Denver – Thank You to Our Members

The 2015 ASHA National Convention was billed as a *November to Remember in Denver!* Attendance was among ASHA's highest on record, 14,059, including 2,779 student members, 1,885 new professional members, 335 life members and 140 international affiliate members. More impressive was the turnout of ASHA members from Colorado: 81% of Colorado ASHA members and students attended, which meant about 20% of Convention attendees were from Colorado. According to ASHA Convention officials, our state's turnout "exceeded any other host state's turnout by a huge margin." Way to go Colorado!!

ASHA officials also reported that more than 80% of Convention attendees said that the Convention in Denver made them feel positive, validated and/or energized. Rumor has it ASHA is already looking to bring the National Convention back to Colorado in the not so distant future!!

Colorado-Wyoming Open House

Equally impressive was the turnout for the Colorado-Wyoming Open House at the Convention, of which CSHA was a proud sponsor. Attendees packed the Adirondack Room in the Tivoli Student Center the evening of Friday, November 13, 2015. Colorado and Wyoming speech-language pathologists and audiologists enjoyed delicious hors d'oeuvres and conversation with alumni, students and colleagues from Colorado University, University of Northern Colorado, Metropolitan State University and University of Wyoming. What a great event!

Pre-Convention Workshops

CSHA contributed in a big way to the record-breaking success of ASHA in Colorado. Some of the Pre-Convention Workshops were provided by professionals living and practicing in Colorado. The goal was to provide attendees with advanced and applied knowledge they could take home and apply in practice the following day. All of the presenters expressed that they felt honored when invited by CSHA to present a Pre-Convention Workshop.

Presenters included:

- Sarah Sogan and Theresa M. Snelling, Pediatric Speech-Language Pathologists with a private office in Lakewood, Colorado, who have years of experience treating and diagnosing children with cleft lip and palate.
- Jose Centeno, Associate Professor at St. John's University in Jamaica, New York, added a bilingual spin to the selections by presenting about clinical management in bilingual individuals with aphasia.
- Kathryn Hardin, Clinical Associate Professor at the University of Colorado, Boulder, presented updates on the diagnoses and treatment of concussions in adolescents and was given the special recognition by ASHA, the *trailblazer award*, for her presentation.

Attendees found the Workshops very useful and rewarding. CSHA will continue its commitment to excellence in continuing education at our Fall Conference with both pediatric and adult tracks and an ICD-10 and billing update.

Renewal of State Certification

The certification requirement for speech-language pathologists in Colorado, HB 12-1303 enacted in 2012, is set to sunset in 2017. This five-year period is standard procedure for new certification laws. Colorado clinicians worked hard to establish speech-language pathology certification in our state in order to protect our consumers from harm by persons who are working in an incompetent, unethical or unauthorized manner. It is critical that our certification continue and CSHA will be working closely this year with our lobbyist and the Colorado Public Policy Analyst reviewing the law to ensure that the legislation certifying SLPs in Colorado is continued.

CSHA has received numerous emails from our members regarding Colorado Medicaid and coding, billing and documentation procedures for codes 92507/97532. An SLP Advocacy Group has been formed to address these issues directly. CSHA is engaged, as is ASHA, in supporting this group who are requesting clarification from Colorado Medicaid on past policy and direction going forward. An email blast was sent to CSHA members regarding a meeting of the advocacy group that was held on Thursday, February 25. Colorado Medicaid has been positively responsive to the advocacy group as well as to ASHA. They are developing a webinar to be held Tuesday, March 22.
